Business Needs:

The principal reason behind Arnold Laver's investment in **Concepts-Online** Explorer was to reduce costs, explains Colin Dean, IT Director. "When trying to maximise profits for any company, you have to look at your overheads and work out where you can make a saving. When we scrutinised our expenses we found that a large percentage of our outlays were on transport, a notoriously difficult cost to reduce". Colin explains "You have a set number of charges that it is impossible to have any influence over, and that anything are going to increase in the future. The price of fuel, for example, is only ever going to go up, service and maintenance fees are fairly static, and we didn't want to be in the position where we were cutting wage rates...so the only option we were left with was making our fleet work more efficiently for us, and that's when we were introduced to the sales team at **Concepts-Online**".

System Installation:

Graeme Oliver, Transport Manager (Bradford), is clearly a proud advocate of the system. 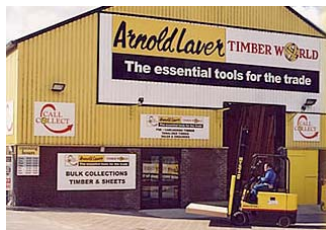
For Graeme, the positive reaction of the drivers has been integral to the success of the system. "Having been a driver myself, I wish I'd had access to something like this... when drivers get lost they phone the office and get exact directions to a customer site, and if for some reason a delivery drop can't be made, the drivers have proof they were on location, eliminating any concerns about a customer complaint".

From a manager's view point, "...the system pays for itself over and over again... the reduction in overtime alone covers the cost of tracking each week... before drivers could take 4 hour lunch breaks and we'd be none the wiser, now they're back in the yard earlier, ready to be sent out on additional jobs we couldn't have accomplished before, or they're back on time without claiming for extra hours wages". "We've also seen the number of 'miscellaneous' journeys made drop substantially. If a driver makes a 5 mile personal trip in one of the trucks, it costs the company about £10. Stopping one trip a week pays for the system for that vehicle again...it's constantly helping us to reduce our overheads".
